1. Job Requirements / Responsibility of the Role

- Responsible for radio operations and upkeep of the broadcasting facility, including periodic checks of the equipment.
- 2. Perform preventive maintenance of the facility including electricity supply (main and UPS) and earthing etc.
- Manage programming (as per the Radio Act for broadcasting), recording, editing, and record keeping of audio files.
- Maintain fresh programs as well as logs/archives of previous programs/broadcasts.
- Schedule programs in consultation with the Station Head/In-charge.

2. Qualifying Requirements:

- (a) Age: Maximum age as on 31 Mar 2025: 30 Years
- (b) Qualifications:
 - Essential: Degree in Electronics & Communication Engineering / Sound Recording from a recognized Institute/University.
 - Desirable: Good voice quality and proficiency in recording software such as Cubase and Nuendo.
- (c) Experience: Minimum 3 years of experience in the Media (Audio/Video) Industry.

3. General Terms & Conditions:

- (a) The candidates will be hired on contract basis and full-time basis, initially for a period of 6 Months to begin with. This period may be extended further based on the requirement of BECIL and satisfactory performance of the candidate.
- (b) The current place of posting will be at *Community Radio Station (CRS), Maharana Pratap University of Agriculture & Technology (MPUAT), Udaipur.* Preference will be given to candidates who can join in the said post on immediate basis.
- (c) Tax deductions will be as per applicable rules.



- (d) Allowances: No allowance such as DA, Residential Telephone, Transport Facility/ Transport Allowance, HRA, CGHS, Medical reimbursement etc. is admissible.
- (e) Candidates are expected to be on duty during normal working hours. However, they may also be required to attend duty on Weekends/Holidays if work demands so.
