- c. There will be no age bar for internal candidates engaged on contractual basis.
- d. All computations of age and qualification etc., shall be as on 31.07.2026. Date of issuance of final mark sheet shall be taken as date of acquiring qualification.
- e. Wherever percentage (%) of marks is not awarded by the University/Institute and only grades (e.g. GPA/CGPA/CQPI) or letter grade in degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by the University/Institute. Where no norms have been specified, the GPA/CGPA/CQPI will be presumed to have been provided on a 10 point scale. The candidate will have to produce a copy of these norms/no norms with respect to his/her University/institute at the time of Personal Interview.
