Sub: Selection for one 'ex-cadre' post of Presenting officer in M/L- 7 (7th PC) Non-Gaz., in Vigilance branch/HQ/Central Railway.

It has been proposed to call for applications from willing Railway employees of Central Railway for selection of 1(One) 'ex-cadre' post of **Presenting Officer (P.O.)** Non-Gaz. in Matrix Level-7 (7th PC), on tenure basis, for working in Vigilance deptt. Of Central Railway, CSMT, Mumbai.

The post is ex-cadre with normal tenure of three years from the date of induction and the administration reserves the right to repatriate the staff to the respective parent cadre on the Railway on or before completion of the tenure without assigning any reason whatsoever.

Selection Process: -

Selection to the posts of PO will comprise viva-voce/APARs/ credibility. Date of viva-voce will be informed in due course.

Eligibility:-

- 1) The staff working in substantive M/ L -7 (7th PC), GP-4600 on regular basis or one level/grade below (not under MACP) and the staff upgraded in Level-8 are also eligible to apply. In the event of employees working in Level-8 getting selected for the post, the PO post in Level-7 will be operated in Level-8 in vigilance branch, on a co-terminus basis. (Authority: Railway Board's letter NO. 2025/V-1/INSP/1/1 dated 19.06.2025). This shall be achieved by transferring selected officials along with their Level-8 posts from the respective Zonal Railways/Production units, with a corresponding transfer of Level-7 posts back to the concerned Railways ensuring no net financial impact.
- 2) The staff should have completed 5(five) years' service (*as on date of issuing the notification*)
- 3) The candidate must have experience in dealing with D&AR cases.

General Conditions

1. Applications must be forwarded through proper channel.
2. Application should be made as per proforma enclosed and must be filled and signed by the candidate himself/herself giving the correct information best to his/her knowledge, especially regarding SPE/Vigilance/DAR cases. No alterations/correction on the application will be entertained. Applicants must note that if any information furnished by him/her are found to be false at any stage, the application/candidature will be summarily rejected. Submission of false or misleading information by applicant will lead to DAR

action. The particulars as submitted by the applicant in his/her application must be Verified and signed by the concerned Supervisor, clearly mentioning own name & designation and office. While verifying the application, any additional information /alteration / correction, remarks made must be signed with date, name and designation by the verifying Authority. For correctness of the information concerned office will be solely responsible and no way Vigilance deptt. will have any responsibility in this regard. Forwarded application must have signature, stamp and office seal of the competent authority.

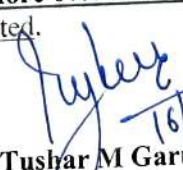
3. The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any major/minor penalty in any past Vigilance case.
4. Past record of Vigilance case would debar the candidate from the selection.
5. The staff should have good reputation and possess good writing ability. Candidates having Computer knowledge will be given preference.
6. The staff should possess sufficient knowledge of Railway Service (Conduct) Rules and Railway Servants (Discipline and Appeal) Rules.
7. The applicants may be specifically advised that the post of **Presenting officer** is a tenure post for three years, but the Vigilance organization reserves the right to repatriate him even earlier without assigning any reason in the case of selection/promotion to the higher grade post.
8. The incumbent will not be eligible for any honorarium during his/her tenure as P.O.
9. Forward applications of all candidates irrespective of cooling off period. The aspect of cooling off period as per HQ policy letter no. CR-HQ/PERS(PUPM)/4/2023/310136 dated 07.03.2024 amended vide letter no. CR-HQ/PERS(PIPT)/3/2024-O/o CPOA/HQ/CR dated 13.06.2024 , should be checked and commented upon while forwarding the applications (Copy enclosed for ready reference).
10. Staff who have already completed their tenure of three years in Vigilance Organization of Zonal Railway/Units/Railway Board as Chief Vigilance Inspector/ Investigating Inspector (Vig.)/RB and have completed sufficient cooling off period (minimum 02 years) as on date of issue of notification are also eligible to apply.
11. Attested Xerox copies of APARs for the years 2021-22 , 2022-23, 2023-24 and 2024-25 of the applicants may please be sent to this office along with the application forms.
12. The candidates whose names have been recommended should be relieved immediately in event of his/her selection as **Presenting officer**.
13. Once selected, applicants will not be permitted to withdraw and refuse posting in vigilance department.
14. No direct applications will be entertained in this office.

It is requested to give wide publicity to this notification, so that eligible candidates can benefit from this.

The last date to submit the applications to the concerned controlling Office/Personnel branch is **31.07.2026** and concerned controlling Office/Personnel branch should forward the eligible applications duly filled and completed in all respect, to Vigilance branch/Central Railway, so as to reach the same in the office of **Vigilance Deptt. / Central Railway, HQR. office, CSMT, Mumbai-400001, positively on or before 07.08.2026 (Friday)**. Applications received after this date will be summarily rejected.
