- (e) **Golf (Men)**: - Sports persons having I.G.U. ranking of 1-20, subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) shall also be eligible for recruitment. 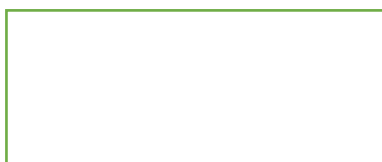
