3) MODE OF SELECTION

- i) Selection of the candidates shall be done based on the Marks scored in the Qualifying Examination i.e., Graduation/Diploma, and Personal Interaction/Interview only, in the order of Merit. Cut off percentage for calling candidates for Personal Interaction/Interview will be decided by the factory based on the total Marks secured in Graduation/Diploma.
- ii) Merit list will be prepared based on combined marks secured in Graduation/Diploma and Personal Interaction/Interview.
- iii) Weightage of Marks in Graduation/Diploma and Personal Interaction/Interview will be 85% and 15% respectively. **Candidates must submit the conversion formula of CGPA into percentage, if they have been awarded CGPA in place of percentage.**
- iv) Preference shall be given to candidate with Graduate (B.E./B.Tech.) in Chemical Engineering or Diploma in Chemical Engineering (in that order), and having Apprenticeship in the manufacturing/handling of ammunition and explosives (Para 2 : Qualification – Serial No. 01). Only in case of non-availability of candidates meeting the criteria at Sl.No. 01, candidates meeting the Educational qualification and Apprenticeship criteria at Sl.No. 02 and 03 (of Para 2 : Qualification) shall be considered (in that order).  - c) B.Sc Graduate with Chemistry as one of the major subjects and having Apprenticeship in the manufacturing/handling of ammunition and explosives.
 - d) Candidate with Graduate (B.E./B.Tech.) in Chemical Engineering and having Apprenticeship in Chemical other than manufacturing/handling of ammunition and explosives.
 - e) Candidate with Diploma in Chemical Engineering and having Apprenticeship in Chemical other than manufacturing/handling of ammunition and explosives.
- v) Candidates qualifying in the Graduation/Diploma and Personal Interaction/Interview will be called for Document Verification in the order of Merit. The number of candidates called for Document Verification will be limited to the number of posts notified. (Discipline / Category wise).

- vi) In case of rejection of candidates during the Document Verification process on account of non-availability of requisite documents / testimonials, not meeting the advertised criteria with respect to Age, Qualification, Experience, etc., additional candidates will be called for Document Verification in the order of Merit (Discipline / Category wise).
