5. ESIC may increase or decrease or cancel filling up of any or all the post without assigning any reasons at the discretion of the Appointing Authority. In case of any discrepancy, All the terms and conditions related with the walk in interview will be valid for and complied with as per this latest advertisement will be final, thereafter if any issue still persist, decision of Medical Superintendent ESIC Korba will be final.
6. No TA/DA will be paid to the candidates for appearing in the interview.
7. Application should be submitted in the prescribed form appended below. It should be filled up in block/capital letters by the candidate in his/her own handwriting.
8. Incomplete or Unsigned applications or the applications received without the self-attested copies of mark sheets/certificates in support of educational qualification, proof of age (Birth certificate or class 10th marksheet), application fee, caste certificate, experience certificates, photographs and those received after the last date of receipt of applications are liable to be rejected without any communication to the candidate.
9. ESIC will not undertake detailed scrutiny of applications for eligibility and other aspects for calling candidates for interview and, therefore, the candidature will be accepted only provisionally. The candidates fulfilling the eligibility criteria for the post will be called for interview on the basis of information furnished by them in the application form. Mere submission of application does not confer any right to the candidates for being called for interview. Before applying, candidates are advised to go through the requirements of essential qualification, age, experience etc. and satisfy themselves that they are eligible for the post. At the time of verification/submission of documents on the day of interview, if any claim made in the application is not found substantiated, the candidature of the candidate will be cancelled and the decision of MS ESIC hospital Korba in this regard shall be final.
10. Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.

12. The candidate who is in service should submit "No Objection Certificate" from the employer at the time of interview.

21. The MBBS or equivalent qualification and Post Graduate Qualification should be recognized by the MCI/NMC/State Medical /Dental Council Chhattisgarh. The candidates are advised to attach the certificate of registration/recognition of their MBBS or equivalent qualification and Post Graduate Qualification with the MCI/NMC/State Medical Council Chhattisgarh. The candidate whose MBBS or equivalent and Post Graduate Qualification is not recognized by the MCI/NMC/State Medical Council Chhattisgarh, he/she will not be eligible for the above post.

22. The selected Full Time/Part Time Specialist will be required to submit certificate of medical fitness from Government Medical Hospital with issuing authority not below rank of Civil surgeon or Assistant Medical superintendent.

23. The selected candidate must have a professional indemnity policy which should cover the period as desired by ESIC. The policy is meant to cover the professional liability falling on them as a result of errors and omissions committed by them while rendering professional services. The minimum sum assured per annum should be
