**A. INVITATION OF APPLICATIONS.**

Online applications are hereby invited from eligible candidates to fill up following various Posts through the URL Address <https://gmag.chdadmnrctt.in> from **01 April, 2026 to 25 April, 2026** till 11.59 P.M.

**1. Procedure/Instructions/Guidelines for Online Filling of Application Form**

Following are all the general and special instructions for the applicant with respect to the online filling of the application form

- a. Apply online well in advance without waiting for last date of submission of online application form.
- b. Please read the instructions and procedures carefully before you start filling the Online Application Form and check all the particulars filled up in application form after getting the printout to ensure the correctness of information and upload all documents before finally submitting the application
- c. The hard copy of application form along with all uploaded documents must be brought at the time when called upon to do so.
- d. No request for change of any particular on the application form shall be entertained later.
- e. No offline application form or copy of downloaded application form will be accepted.

**2. Special Instructions for filling application form**

- a. The online application can be filled up using URL address i.e <https://gmag.chdadmnrctt.in>.
- b. The decision of the department in all matters relating to acceptance or rejection of an application, eligibility/suitability of the candidates, mode and criteria for selection etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
- c. Candidates applying for the post must ensure that they fulfil all the eligibility conditions on the last date of application i.e., 25 April, 2026.
- d. If on verification at any stage starting from submitting application form till appointment and any time even after appointment, it is found that any candidate does not fulfill any of the eligibility condition or it is found that the information furnished is false or incorrect, his/her candidature will be cancelled.
- e. Govt. Museum Art & Gallery, Chandigarh reserves the right to call any candidate personally along with printed copy of the application form with uploaded documents original certificates and photocopy of self-attested certificates along with Photo Identity Proof i.e. Identity Card/Driving License/Passport/Voter Card/Pan Card/Aadhaar Card etc.

**B. QUALIFICATIONS AND SELECTION CRITERIA FOR THE FOLLOWING VARIOUS POSTS:**

**1. CHEMIST:**

**Number of Post: 01 (GEN) (CPC Pay Level-6)**

**Qualification:**

- (i) Master's degree in second division from a recognised University or equivalent in physical or in organic or in Analytical Chemistry.**
- (ii) Experience of analysis of alloys, silicates and knowledge of insecticides, fumigants and plastics.**

**Desirable**

**Preference will be given to those who have one year experience regarding Archaeological work and treating antiquities in Government Institutions/ reputed institutions.**

**Probation Period: 02 Years:** The minimum of pay scale/matrix along with other allowances will be paid during the probation period of 02 years and during the extended period of probation, if any as per the guidelines issued by the Government from time to time.

**Age Criteria:**

The age limit for the post of Chemist is 18-35 years (Relaxable for Govt. Servant up to 05 years in accordance with the instructions of Govt. of India). Age is to be calculated as on closing date of application.

**2. LIBRARIAN:**

**Number of Post: 01 (GEN) (CPC Pay Level-6)**

**Qualification:**

- (i) Master's degree of a recognised University or Institution;**
- (ii) Diploma in Library Science of a recognised or institution.**

**Probation Period: 02 Years:** The minimum of pay scale/matrix along with other allowances will be paid during the probation period of 02 years and during the extended period of probation, if any as per the guidelines issued by the Government from time to time.

**Age Criteria:** The age limit for the post of Librarian is 18-35 years (Relaxable for Govt. Servant up to 05 years in accordance with the instructions of Govt. of India). Age is to be calculated as on closing date of application.

**3. PROJECTIONIST:**

**Number of Post: 01 (GEN) (CPC Pay Level-4)**

**Qualification:**

- (i) Matriculation or equivalent examination passed;**
- (ii) Licence for operating Cinematography.**
- (iii) One year's course in General Mechanics and 3 years experience of a projection work in a cinema or an auditorium.**

**Probation Period: 02 Years:** The minimum of pay scale/matrix along with other allowances will be paid during the probation period of 02 years and during the extended period of probation, if any as per the guidelines issued by the Government from time to time.

**Age Criteria:** The age limit for the post of Projectionist is 18-32 years (Relaxable for Govt. Servant up to 05 years in accordance with the instructions of Govt. of India). Age is to be calculated as on closing date of application.

#### 4. Caretaker:

**Number of Post: 01 (GEN) (CPC Pay Level-2)**

**Qualification:**

- (i) **Matriculation or equivalent examination passed.**
- (ii) **Experience of security arrangements of a big building and;**
- (iii) **Able to keep records, make reports and enforce discipline and check standard of cleanliness.**

**Desirable:**

Three years experience in the Indian Army or the Police force of the Chandigarh Administration or Central Government or any State Govt.

**Probation Period: 02 Years:** The minimum of pay scale/matrix along with other allowances will be paid during the probation period of 02 years and during the extended period of probation, if any as per the guidelines issued by the Government from time to time.

**Age Criteria:** The age limit for the post of Caretaker is 18-30 years (Relaxable for Govt. Servant up to 05 years in accordance with the instructions of Govt. of India). Age is to be calculated as on closing date of application.

**Each Question will carry one mark and there will be no negative marking. Written test of all candidates for all posts shall be conducted.**

##### a) **CHEMIST**

##### c) **PROJECTIONIST**

- Aptitude (Reasoning Verbal & Non-verbal) : 10 marks

**d) CARETAKER**

Written Test of all eligible candidates : 100 Marks

Difficulty level of question will be 10<sup>th</sup> standard

- English : 20 marks
- General Knowledge : 20 marks
- Aptitude (Reasoning Verbal & Non-verbal) : 20 marks
- Computer and IT based : 20 marks
- Numerical Ability : 20 marks

**E. Examination Schedule:** The OMR based Examination is likely to be held on 02.05.2026. The date, time and place of examination will be as per admit card. Examination will be conducted in Chandigarh only. However, department reserve the right to reschedule/change the above schedule on administrative grounds or otherwise. Applicants are advised to regularly visit the website/link as no separate individual intimation shall be sent.

**Note:-**

1. Difficulty level of questions will be as per essential qualification.
2. Minimum Qualifying marks will be 35%.
3. Written test will be held in Chandigarh only.
4. There will be No Negative marking.
5. The Question Paper will be in English medium only.
6. In case of candidates scoring equal marks in written test, preference will be given to those who are higher in age.
7. Application fee of Rs.1000/- is Non-refundable.
8. The department reserves the right to reject/cancel any application without assigning any reason.
9. Qualifications and other term and conditions of eligibility will be determined with regard to the last date fixed for receipt of online applications also termed as closing date.
10. No individual information at any stage shall be sent and hence all candidates should regularly visit the website or public notice in different Newspaper for any information/ update.
11. If on verification at any stage starting from submitting application form till appointment and any time even after appointment, it is found that any candidate does not fulfil any of the eligibility condition or it is found that the information furnished is false or incorrect, his/her candidature will be cancelled.
