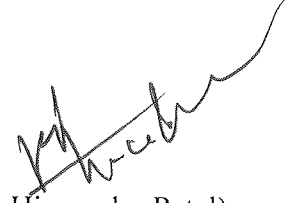

4. After further process, tentative date for joining will be 1st August, 2026.
5. Candidates who desire to apply for more than one post will be required to submit separate Online Applications on the prescribed format along with all the specified supporting documents along with each application.
6. Candidate has to upload his/her necessary documents i.e. qualification, experience, caste, age, other documents in the online application portal as per the instructions given in Annexure-I.

3. Scanned copies of Candidate's all necessary copies of testimonials, certificates and documents in PDF format (the digital size of the PDF file should be less than 500 KB).

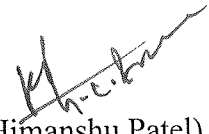
STEPS TO BE FOLLOWED FOR FILLING THE ONLINE APPLICATION
