1. Foreman

B.E/B.Tech. first class in Mechanical/Production Engineering or its equivalent from a recognized University.

2. Junior Stenographer

Graduate from any recognized University having minimum speed of 65 and 35 words per minutes in shorthand and type writing respectively and a six months certificate course in Computer Applications from a recognized Institute.

3. Workshop Assistant

Matriculate with National Trade Certificate from recognized Technical Institute with three years experience in -

1. Foundary Smithery
2. Sheet Metal
3. Machine Shop
4. Carpentry/Woodworking
5. Fitting and Welding

4. **Accounts Assistant**

Graduate in any stream from any recognized University with minimum of 50% marks for open merit and 45% marks for reserved categories. However, candidates having Post-Graduate Degree with 50% marks or holding Ph.D. Degree or equivalent shall also be eligible for selection to the post of Accounts Assistant.

5. **Workshop Instructor**

Matriculation with 3 year Diploma in concerned Trade from recognized Institute.

6. **Lab. Technician (Civil/CSE)**

Diploma in the appropriate discipline i.e. Civil/Computer Engineering with five years experience.

GENERAL INSTRUCTIONS:

1. The Candidates applying for the aforesaid positions should be domiciles of the Union Territory of Jammu and Kashmir and have to upload the Domicile Certificate issued by the Competent Authority on the format prescribed for the purpose.
2. The applicants are required to produce printout of completed ONLINE application form (Hardcopy) duly self-attested, along with supporting documents at the time of skill test/trade test/Computer Test/Interview etc. or as and when sought by the University failing which such candidates shall not be allowed to participate in the further process of selection.
3. Horizontal reservation shall be granted as per the norms.
4. Age as on 01/01/2026
 - i) Minimum for all candidates: = 18 years
 - ii) Maximum for:
 - a) General Candidates = 40 years
 - b) SC/ST1/ST2/Backward Area (RBA)/EWS (Economically weaker Section)/Other Backward Classes (OBC)/ALC/IB candidates = 43 years

- 6. Candidates should carefully read the requisite minimum essential qualifications and experience criteria etc. laid down in the advertisement before applying for these posts. - 8. Candidates who have successfully submitted their applications have to ensure that their name appears in the list which would be available after the last date of the advertisement on the website. - 9. Only those candidates should apply for these posts who fulfil the eligibility criteria on or before the last date of submission of the online application. No correspondence will be made with applicants who are not shortlisted/called for screening test and/or interview and/or Trade/skill test etc. The University shall, however, not be responsible for any postal delay/lapse.

- 13. Canvassing, in any form, by or on behalf of the candidate will summarily disqualify the candidate.
