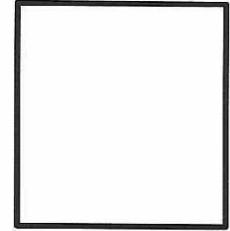
- The engagement will be on whole time appointment basis and will have no right of private practice during the period of contract.
