5. **Bachelor's Degree Certificate** issued by the concerned University. If any candidate claims to possess qualification, equivalent to the prescribed qualifications, the rule/ authority (with number & date) under which it is so treated must be furnished.
6. Mark sheets of all Semesters / Annual Examination in support of all the aforesaid Examinations (H.S.C. to Bachelor's Degree) passed including fail marks, if any, issued by the Board/Council/University concerned.
7. Conversion Certificate/Conversion Formula (CGPA to Percentage), wherever applicable.
8. **Odia Test Pass Certificate.**
9. **Caste Certificate by Birth** in support of claim as SC/ST/SEBC issued by the Competent Authority within the closing date of Online Application. SEBC Certificate must be issued within the last three years from the closing date for submission of Online Application Form.
10. **Sports Certificate/Identity Card** issued by Director of Sports, Odisha, if any.
11. **Permanent Disability Certificate** (including Percentage of Disability i.e. 40% or more) issued by the concerned Medical Board, wherever applicable.

17. **Any other relevant documents as per Para-10 of the Advertisement.**

The candidates are required to mention "**Submitted by me and Certified as genuine and has not been cancelled**" and put their full signature and date on the photocopies of Certificates/Documents.
