Eligibility criteria and terms & conditions: -

- 1. The Officers working in all Department (Except Security & Medical) in SEC Railway can only apply for the post of Sr. Inquiry Officer, under SDGM/SECR.
- 2. The Officers working in Sr. Scale in Pay Matrix Level-11 (PB-3 Rs.15600-39100/- + GP Rs.6600/-) are eligible to apply for the notified post.
- 3. The application of officers in Junior Scale (JS) in Pay Matrix Level-8 to 10 having adequate knowledge & experience of dealing with DAR matters may also be considered. They will be posted in the same grade by downgrading the post of Sr. IO for the time being. The officers in JS will be considered only in case he suitable SS officer is not found fit for the post 4. The normal tenure of the Sr. Inquiry Officer will be 04 (four) years.
- 5. The officer so selected will be sent back to their former post as and when the
- tenure is completed, or repatriated even early by the administration. 6. The officer should have knowledge of DAR rules and inquiry proceedings.
- 7. The Officer so selected for the post of Sr. Inquiry Officer will be posted to the notified post against the Sr. Scale post provided by the General cadre.
